Thank you for taking the time to meet! As the HEERF Awards for Bay College are currently in liquidation status, no new activities would be allowable. However, as we spoke about on the phone, you may use this time to redistribute uncashed checks to students. The guidance provided is below:

- The student(s) receiving the redistributed checks must have been eligible during the performance window and have met the eligibility criteria previously established.
- As the uncashed checks are coming from the institution award (F award) you may use the distribution to discharge student debt. For example, if a student was eligible for HEERF during the performance and has a negative balance with the institution, you may use this redistribution to bring the students account positive.
- As this activity was already expressed in the quarterly report in which the activity took place, no new or amended quarterly report is required.
- If a new or amended quarterly report is to be posted, please keep the original and post the revised report with the word "revised" in the file name.

If the funds will be used to cover activities that occurred during the performance window but is not the redistribution of student aid, you will need to post a revised quarterly report for which the activity occurred that includes this additional expense. Please remember, it may not be a new activity or expense that has occurred outside of the performance window. For example, you may not purchase HVAC filters today and claim these funds as it did not occur prior to June 30, 2023. However, if you purchased HVAC filters prior to this date and are using the HEERF Institution award, you will need to reflect this expenditure on the appropriate quarterly report.
